Dear Mr. Korman,

We are aware of a presentation made by Chabad Lubavitch to the court in which 'chabad activities' are listed for Estonia.

We have to state that Chabad as an independent movement does not exist in Estonia. Indeed our community rabbi, Shmuel Kot, belongs personally to the Chabad movement, but our contract with him states clearly that he does not represent Chabad, but purely and exclusively the Jewish Community of Estonia. Therefore all the activities conducted by Rabbi Kot are, in fact, Community activities and not Chabad activities.

We are satisfied with the system what is organised by JDC.

We had no complaints from clients of our Welfare Center and consider not expedient to change this system.
