Dear Chief Justice Edward R. Korman and Special Master Judah Gribitz,

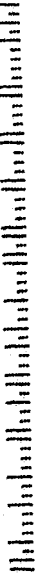

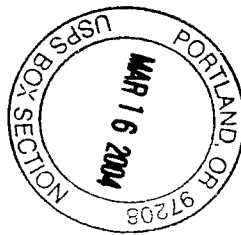

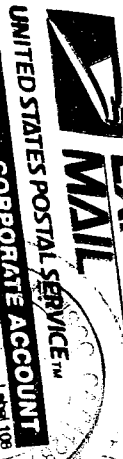
