1. Number and location of Nazi victims

a) Estimate number

It is extremely difficult to locate the sorts of sources about Gypsies in the Holocaust of the type widely available about Jewish victims of the Nazi terror. This may reflect difference between an extremely literate culture and a largely illiterate one. Due to many resources it is estimated that number of Roma who died in Europe estimates range from 220,000 to 500,000. (Source: Dr. William L. Shulman, *A State of Terror: Germany 1933-1939*. Bayside, New York: Holocaust Resource Center and Archives.) Today there are more than 14 million Roma living in Europe.

In Croatia, members of the local fascist Ustasha movement killed hundred of thousands of Roma. Just in one concentration camp, Jasenovac more than 71,000 Roma were killed. More than 400,000-500,000 Roma from the area of Republic of Croatia and Bosnia and Herzegovina were killed, detained and persecuted (Acković, 2002.). State counting from 1931 is saying that there were in Yugoslavia 64.909 people whose language was Romani, but also there were 70.203 who did not say anything what is pointing us that there were a lot more Roma living on that area. Additionally, Roma who were living nomadic way of life were not comprehended with the state counting, what is majority of Roma.

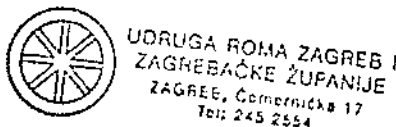
Survived victims and document are saying that during 1942 most of Roma detained in concentration camps were not counted in any official documents, that they were counted by trucks and the existing lists just adult men's were mentioned.

The reason why we mentioned above number of 400-500,000 Roma victims of Holocaust is because the most of Roma living on the area of Republic of Croatia were detained or killed in their houses, woods, on the road, placed in small camps, which are not officially noted.

Today there are more than 300 of the survived victims of Holocaust still living in Republic of Croatia and more than 1200 members of their families.

b) Source materials upon which data is based, including any expert opinion(s) relied upon

Data are based on materials collected from Roma NGOs from this area, documentation of existing camps, declarations from survived victims (declarations are collected from more than 200 persons). Also based on the opinion of Mr. Ackovic, Mr. Rajko Djurić, Mr. Hancock, Mrs. Narcisa Lengel-Krizman and others.



2. Number and location of needy Nazi victims

a) Estimates of victims

Almost all Roma living today in Republic of Croatia are poor, but according to our experience more than 80% of Roma can be considered needy and need help. Today there are more than 300 of the survived victims of Holocaust still living in Republic of Croatia and more than 1200 members of their families, so we could say that there are 240 needy survived victims of Holocaust and more than 960 members of their family.

b) Source materials upon which data is based, including any expert opinion(s) relied upon

Data are based on researches from the World Bank, researches done by Institute for social research of Republic of Croatia, data collected from Social work centers and Ministry of labor and social welfare of Republic of Croatia and Roma NGOs.

3. Needs of survived victims

During year 1995 to 1999 Roma Association Zagreb and Zagreb County collected documentation of more than 200 Roma and more than 1000 members of their families, survived victims of Holocaust and hereby we will explain their needs.

According to official figures more than 400 000 Roma from area of Republic of Croatia and Bosnia and Herzegovina suffered, were killed, or a member of their family was killed in Holocaust. The one who survived are today living in Republic of Croatia.

When we are looking at the number of Roma detained or killed in Holocaust we can not ever have exact numbers since there are several researches which are saying that most of Roma living on this area were never comprehended with any state counting, especially children.

a) Analysis of specific need of survived victims

Victims mentioned above are mostly old people with specific needs, especially health care needs (food, shelter, medicines, medical check ups etc.). Most of them need help of care organization in their homes which is in Croatia left to private organization and they Roma people can not afford it. Old people homes don't have enough facilities for old people living in Croatia and people have to wait for several years to get a placement in old people's home. Situation is even worst for people who can not pay for old people's homes such as Roma.

Unemployment rate in Republic of Croatia is more than 20% but among Roma it is 80-96,8%, most of them working on the black market collecting old iron, reselling used stuff.. Reasons for that high unemployment rate is low level of education, no programs of subsidies for employing Roma although there are for handicapped, students, graduates, old workers, war veterans and their families and most often reason for such high unemployment rate is discrimination. The Roma families that enjoy a better social and economic status have secured this by working in Western Europe, same as many non-Roma from the South East European region in general.

According to some researches there are **38,52% illiterate Roma**, 86,06% didn't finished even primary school. More that 51,97% are pre-school children, only 3,49% people under age of 55. Among 12.000 Roma living in Zagreb just 120 children are attending secondary school and there is just one student in whole Republic of Croatia. The reason for that is segregation within school, prejudices, no educational programs on Roma language (romani chib), lack of an organized and funded support (with scholarships). This problem is one of the recognized priorities of the local Roma associations and various projects that aid



the children and youth in preserving their interest in education have been launched, always with minimum financial means – thus the results are still far from being satisfying.

Even today Roma living in Republic of Croatia face institutional discrimination on all levels. Roma people in Republic of Croatia are speaking Romanes (romani chib) but there are no educational schemes on Roma culture and history also within regular schools book any chapters on Roma history and customs. They're about twenty Roma dance clubs organized in Croatia, but no theatre, Cultural center. All the other national minorities in Republic of Croatia are protected from the government and have Cultural centers, where they can preserve their culture and are founded from the government just Roma national minority is left out any government founded programs.

The Roma love to participate in cultural programs and almost every local Roma association has some sort of a cultural workshop and cultural programs where Roma participate. A lot of racist speech towards Roma in Croatian media, no Roma radio or Roma radio program. There is one Roma newsletter edited in Republic of Croatia "Romengo Čaćipe" (not founded from the Croatian government).

Roma houses are situated in very poor neighborhoods, with no access to adequate housing, no electricity in more that 40% of settlements and most of those are illegal, more than 80% have no running water. Without access to public services (social, health services...), very far from schools, public transport, hospital, playgrounds etc. Build on very unhealthy land, (industrial zone, near dump yards..) what causes different chronicle diseases and is reducing their life. Since there were no social programs in the Republic of Croatia in the last 10 years the Roma have also not benefited from any social housing programs, people are very often evicted, relocated from one place to another, not permitted to have permanent residence... In year 2001 Republic of Croatia brought out new housing program but there are no programs for Roma.

All of this leading to Roma, survived victims of Holocaust of being left out from any social and health programs, living in their houses without any medical help, very poor nutrition, without running water, heath, shelter etc.

Croatian government in many cases refused to issue Croatian citizenship to Roma people that have been born in Croatia, especially those during WW II or have lived in Croatia for many years before the Homeland war in the 90'. In particular, in the order to receive new documents after the independence of the Republic of Croatia in 1990/91. every Croatian citizen had to register in the book of citizens. In the order to do this, administrative databases where the prime source of information for the officials. Files regarding many Roma people have simply disappeared, thus the Roma were not able to register as Croatian citizens and actually became refugees; situation is even worse for people born in Former Yugoslavia countries.

b) Survivor longevity estimates by geographic location

Expected living time in Republic of Croatia is 76 years (State statistics, 2001.) and in Europe 74 (Prinz, 1997.) but according to research done in year 2001. (Lovrić, 2001; Štabi, 2002.) for Roma national minority it is much less, not more than 60-65 what is saying about lower living condition for Roma especially the victims of Holocaust.

According to 1991. year Republic of Croatia counting Croatia has 4,7 million citizens and 6.695 of them are Roma, figures from 2001 counting are not much better and saying that there are 9700 Roma living in Republic of Croatia. But according to OSCE there are 40.000 Roma and according to Roma NGO data there are 80-110 000 Roma living in Republic of Croatia today. The biggest concentration of Roma is around bigger cities Zagreb, Rijeka and Bjelovar and in Međimurska County, Požeško-Slavonska County.

b) Absolute and relative poverty levels

Poverty in Croatia, according to international definition (4,3 US\$ per day), is 4,8%. According to Croatian national line 15.474 HRK yearly/adult person is 10,0% and according to relative lines it is more than 13,5% (World bank, 2000.)

There are no official figures on the number of Roma who we could consider poor. However, research done in year 2000. in one Croatian county is saying that there were more Roma beneficiaries of social benefit than there were Roma on that area according to state counting 1991. As beneficiaries of social benefits are *means tested* and can be just persons who according to the lines mentioned above are considered poor we can say that almost all Roma living today in Republic of Croatia are poor, but according to our experience more than 80% of Roma can be considered needy and need help.

5. Recommendation for agency

a) Description of prior experience

Roma Association Zagreb and Zagreb County in its work since 1993, has proven it's organizational abilities, especially through membership in Board for improvement of living conditions in Roma settlements in cooperation with city of Zagreb representatives and ministries representatives.

During the Homeland war in 90' Roma have suffered for once more time persecution and discrimination on all fields what brought to large number of Roma without food and shelter. Therefore our association **organized humanitarian help from all around a world** and more than 5000 packages are distributes and shelter organized for more than hundred families.

Roma Association Zagreb and Zagreb County, is non-for profit, charitable organization, founded in year 1993. on initiative of Roma national minority with an aim to promote their human and minority rights, improvement of quality of lives and improvement of their inclusion into society.

Aims according to Association Statutory also comprehend: developing and organizing educational programs, cooperation with local and national government, Roma NGOs and INGOs, collecting and dissemination of humanitarian help, organizing sport activities, cultural activities.

Bodies of Association: General Assembly, Presidency, Board of Directors and Supervision Board. President of Association is responsible for legitimacy of work.

Association has no full time employees, just part time but with active work of its Boards, President and volunteers is containing quality of work.

Beneficiaries are all Roma in Republic of Croatia, more than 3000 members just from area of city of Zagreb and Zagreb County.

During it's long term work Association cooperated with many NGO. We would like to highlight several activities:

- **Counseling help** in getting human, social, economic and cultural rights i.e. citizenship, rights from health insurance, social insurance, unemployment benefits
- **Each year tradition commemoration** is organized to Jasenovac camp, from WWII, where more than 71 000 roma are killed
- From 14th to 16th of February 2003. **organized 1st Roma Congress in Republic of Croatia**, more than 60 representatives from more than 30 Roma NGOs from Croatia participated. Conclusions from the Congress were submitted to Croatian government and added to National program for Roma
- Organizing **traditional celebration of World Roma Day**, 8th of April, especially in year 2002. when we noted 1000 years of *pajoramus*. Traditional celebration is consisted of Round table with the government and municipalities, presentation of Roma culture and arts, organizing exhibitions etc.
- **Roma Soccer club** competed in 3rd Croatian league and had great results, especially on the area of city of Zagreb and Zagreb County.
- **Organization of the seminar** on social welfare and health care
- **Organized summer school for children**

- **Organizing actions in improvement of quality of life in Roma communities,** settlements by lobbying the government, ensuring means for getting facilities into the settlements (roads, drinking water, electricity, heat etc.)
- **Organized collection and dissemination of humanitarian help**
- **Edition of only magazine of Roma national minority in Republic of Croatia «Romengo čačipe» (Roma truth),** it is edited for the 7th year now and its 18th edition was published in year 2003, printed in 2000 copies on romanes, Croatian and English language, distributed to 30 countries and available at the following web site: www.umrh.hr
- **Initiated edition of first Roma- Croatian language dictionary,** until today words have been collected by our organization, lector was found and is to be elected during this year

- **Activities of Roma Youth Club in Zagreb,** established in year 2000 were more than 60 children were included in PC training during year 2002/2003 and are self-organized in PC group. - **Organizing prevention programs for children** in order to prevent alcohol and drug abuse
- **Initiator of foundation of Roma cultural Center** in Republic of Croatia
- **Participated on different conferences,** 1998 Conference of International Romani Union (IRU) in Washington, Conference of IRU in Prague, 2000; UN World Conference Against Racism, 2001;
- **Drafted *Program of revitalization of Roma national minority in Republic of Croatia.***
