## To Whom it may concern

In the name of the Presidium of the Jewish Confederation of Ukraine we would like to request your support for our distribution plan of the Swiss fund allocations in the New York Court. We propose the following distribution plan for the Jewish part of fund:

1. **55% - Direct cash payments to Jewish victims of the Holocaust who lived in a country at a time when it was under Nazi regime, under Nazi occupation, or under the regime of Nazi collaborators. Payment should be made to their heirs in case of the survivors death.**

**45 %- payments for Jewish communities of countries that went through Holocaust.**

2. **Allocations should be made to the communities proportionally, based on the Jewish population in those countries at the period before the fascist occupation.**

3. **Above mentioned allocations should be sent directly to communities of countries that went through Holocaust and their use should be supervised by international auditing firms. Communities should make plans for the use these funds including the following types of activities:**

- **Services (food, home care, etc.) to be provided to Jewish victims of the Holocaust;**
- **Memorialization of Mass graves of Jews who were killed during the Holocaust;**
- **The creation of museums and memorials of Holocaust in every country of above mentioned;**
- **Social programs for men who suffered from Holocaust. There are not less than 150 thousand people of such category in Ukraine and their pension is 10-15 dollars in month;**
- **Educational programs for Jewish schools . There are 18 full day schools and near 60 Sunday Jewish schools for 10 thousands children in Ukraine;**
- **Programs for feeding the poor students of Jewish schools;**
- **Educational programs for non-Jewish schools devoted to the Holocaust;**
- **Youth programs: clubs by interests , summer and winter camps;**
- **Teaching Jewish culture and heritage;**
- **Restitution and reconstruction of Jewish communal property. There are nearly 2000 objects of Jewish communal property (real estate) that have not been returned and**

- nearly 1000 Torah scrolls that are stored in unsuitable conditions in archives and museums throughout Ukraine;
- The support of the Jewish religion and Jewish social activity;
- Other programs and projects.

International organizations that want to take part in the development and in the realization of such projects in communities that went through Holocaust are able to propose their projects and programs to communities and to take part in tenders on more effective use of funds.


